**TUYỂN SINH ĐI HỌC TẠI HUNG-GA-RI ĐIỆN HIỆP ĐỊNH NĂM 2023**

Căn cứ Thông tư số 06/2016/TT-BGDĐT ngày 21/3/2016 của Bộ trưởng Bộ Giáo dục và Đào tạo ban hành Quy chế tuyển sinh đi học nước ngoài; Căn cứ Thỏa thuận hợp tác giữa Bộ Giáo dục và Đào tạo Việt Nam và Bộ Ngoại giao và Kinh tế đối ngoại Hung-ga-ri về Chương trình học bổng Stipendium Hungaricum giai đoạn 2022-2024, Bộ Giáo dục và Đào tạo thông báo tuyển sinh đi học tại Hung-ga-ri điện Hiệp định năm 2023 như sau:

**1. Thông tin chung về chương trình học bổng**

**1.1. Tên chương trình học bổng và cơ quan phụ trách**

- Tên chương trình học bổng: Chương trình học bổng đi học tại Hung-ga-ri điện Hiệp định năm 2023 (tên chương trình phía Hung-ga-ri: "*Stipendium Hungaricum Programme*") (SH)).

- Cơ quan phụ trách:

+ Phía Việt Nam: Cục Hợp tác quốc tế - Bộ Giáo dục và Đào tạo;

+ Phía Hung-ga-ri: Tempus Public Foundation (sau đây gọi là Quỹ Tempus).

**1.2. Số lượng học bổng, trình độ đào tạo và ngành học**

- Chính phủ Hung-ga-ri cấp 200 học bổng cho công dân Việt Nam đi đào tạo tại Hung-ga-ri theo trình độ đại học (cử nhân), thạc sĩ liên thông từ đại học (OTM), thạc sĩ (MA/MSc) và tiến sĩ.

- Chỉ tiêu học bổng như sau:

+ 90 học bổng đại học về Khoa học Nông nghiệp, Nghệ thuật và Nhân văn, Khoa học Xã hội, Khoa học Máy tính và Công nghệ Thông tin, Khoa học Kinh tế, Khoa học Kỹ thuật, Khoa học Sức khỏe, Đào tạo giáo viên, Khoa học Thể thao, Khoa học Tự nhiên, Nghệ thuật và Giáo dục Nghệ thuật;

+ 55 học bổng thạc sĩ (MA/MSc) trong các lĩnh vực Khoa học Nông nghiệp, Nghệ thuật và Nhân văn; Khoa học Xã hội, Khoa học Máy tính và Công nghệ Thông tin, Khoa học Pháp lý, Khoa học Kinh tế, Khoa học Kỹ thuật, Khoa học Y tế và Sức khỏe, Đào tạo Giáo viên, Khoa học Thể thao, Khoa học Tự nhiên và Nghệ thuật;

+ 25 học bổng chương trình đào tạo thạc sĩ liên thông từ đại học trong các lĩnh vực Khoa học Nông nghiệp, Khoa học Kỹ thuật, Y tế và Khoa học Sức khỏe, Nghệ thuật;

+ 30 học bổng tiến sĩ trong các lĩnh vực phù hợp với nhu cầu xây dựng và phát triển nguồn nhân lực của địa phương, cơ quan cử đi học hoặc ngành học đã tốt nghiệp ở trình độ đào tạo trước đó.

- Ngành học chi tiết được công bố trên cổng thông tin điện tử của Quỹ Tempus ([www.tpf.hu](http://www.tpf.hu)) và (<https://stipendiumhungaricum.hu/partners/>).

### **1.3. Thời gian đào tạo**

- Chương trình đại học: từ 03 năm đến 04 năm học;
- Chương trình thạc sĩ: từ 1,5 năm đến 02 năm học;
- Chương trình thạc sĩ liên thông từ đại học: 05 năm đến 06 năm học;
- Chương trình tiến sĩ: 04 năm.

### **1.4. Chế độ học bổng**

- Học bổng của Chính phủ Hung-ga-ri cấp cho 200 chỉ tiêu bao gồm: miễn phí đào tạo, nghiên cứu, cấp bảo hiểm y tế và hỗ trợ chỗ ở, sinh hoạt phí theo quy định của phía Hung-ga-ri.

- Trong số 200 chỉ tiêu được Chính phủ Hung-ga-ri cấp học bổng sẽ có 100 chỉ tiêu được cấp bù học bổng của Chính phủ Việt Nam bao gồm: vé máy bay một lượt đi và về, phí đi đường, lệ phí làm hộ chiếu, visa và sinh hoạt phí theo chế độ hiện hành (nếu đáp ứng được các yêu cầu tại mục 2.3.2 của thông báo này).

## **2. Điều kiện và đối tượng dự tuyển**

### **2.1. Điều kiện chung**

Ứng viên dự tuyển cần đáp ứng đầy đủ các điều kiện chung sau đây:

- Là công dân Việt Nam, có phẩm chất chính trị, đạo đức tốt; không trong thời gian thi hành kỷ luật hoặc trong thời gian đang bị cơ quan có thẩm quyền xem xét xử lý kỷ luật.

- Đủ sức khỏe để học tập tại nước ngoài.

- Chưa đăng ký dự tuyển chương trình học bổng nào khác tại cùng thời điểm với thông báo này (từ khi thông báo này có hiệu lực đến khi có kết quả sơ tuyển).

- Cam kết hoàn thành chương trình đào tạo và trở về nước công tác. Đối với các ứng viên được cấp bù học bổng của Chính phủ Việt Nam không hoàn thành chương trình đào tạo, tự bỏ học, bị buộc thôi học hoặc sau khi tốt nghiệp không trở về nước phục vụ, không thực hiện đầy đủ nghĩa vụ của người được cấp học bổng phải đền bù kinh phí đào tạo theo quy định hiện hành.

- Về độ tuổi:

+ Ứng viên đăng ký đi học đại học và chương trình thạc sĩ liên thông từ đại học cần sinh trước ngày 01/9/2005 (trừ ứng viên đăng ký ngành múa);

+ Ứng viên đăng ký đi học thạc sĩ, tiến sĩ không quá 40 tuổi tính đến ngày 16/01/2023.

- Về kết quả học tập:

+ Ứng viên là học sinh lớp 12 đăng ký đi học đại học phải có điểm trung bình chung từng năm học THPT đến hết năm học 2022 - 2023 đạt từ 7,0 trở lên và có kết quả trúng tuyển vào một trường đại học năm 2023 khi làm thủ tục đi học;

+ Ứng viên là sinh viên đăng ký đi học đại học phải có điểm trung bình chung từng năm học THPT, điểm xét tốt nghiệp và điểm trung bình chung học kỳ 1 đại học đạt từ 7,0 trở lên (theo thang điểm 10 và tương đương).

- Về trình độ đào tạo:

+ Ứng viên chỉ được đăng ký dự tuyển trình độ đào tạo cao hơn trình độ đã có văn bằng;

+ Đối với trường hợp tốt nghiệp đại học, thạc sĩ ở nước ngoài không do Bộ Giáo dục và Đào tạo cử đi học hoặc tốt nghiệp các chương trình đào tạo phối hợp với nước ngoài tại Việt Nam cần có giấy chứng nhận văn bằng do Cục Quản lý chất lượng - Bộ Giáo dục và Đào tạo cấp.

- Về ngành học:

+ Ứng viên dự tuyển trình độ đại học và thạc sĩ liên thông từ đại học phải đăng ký dự tuyển ngành học cùng khối ngành với ngành đã trúng tuyển và đang học đại học ở Việt Nam hoặc ngành đã đoạt giải thưởng quốc tế (huy chương vàng, bạc, đồng), giải thưởng quốc gia (giải nhất, nhì, ba).

+ Ứng viên dự tuyển trình độ thạc sĩ, tiến sĩ phải đăng ký dự tuyển ngành phù hợp nhu cầu xây dựng, phát triển nguồn nhân lực của cơ quan, địa phương cử đi học, phù hợp với vị trí việc làm, nhu cầu công tác của cơ quan hoặc ngành học đã tốt nghiệp ở trình độ đào tạo trước đó.

+ Ứng viên được đăng ký dự tuyển tối đa 02 chuyên ngành đào tạo theo quy định của phía Hung-ga-ri (phù hợp quy định về ngành học và xếp theo thứ tự ưu tiên). Ứng viên không được tự ý thay đổi ngành học, cơ sở đào tạo sau khi đã đăng ký dự tuyển, trúng tuyển đi học theo thông báo của Bộ Giáo dục và Đào tạo Việt Nam, Quỹ Tempus và cơ sở đào tạo tại Hung-ga-ri.

- Không xét tuyển ứng viên thuộc các trường hợp sau:

+ Đã được Bộ Giáo dục và Đào tạo cử đi học ở nước ngoài nhưng không hoàn thành khóa học hoặc không thực hiện việc báo cáo tốt nghiệp theo quy định;

+ Đang làm việc tại cơ quan nhà nước, cơ sở giáo dục nhưng hồ sơ dự tuyển không có văn bản của cơ quan trực tiếp quản lý đồng ý cử dự tuyển;

+ Đã được cấp học bổng đi học đại học/sau đại học ở nước ngoài, hiện có các ràng buộc về nghĩa vụ, trách nhiệm hoặc thuộc diện đền bù kinh phí đào tạo;

+ Đã được tuyển chọn đi học nước ngoài nhưng không đi học vì lý do cá nhân (thời hạn áp dụng là 02 năm kể từ ngày nộp đơn xin rút không đi học);

+ Đã được cấp học bổng của Quỹ Tempus năm học 2020-2021, 2021-2022, hoặc 2022-2023 nhưng sau đó từ chối học bổng hoặc không sang nhập học, không thông báo với Quỹ Tempus cho đến ngày 31/8 của năm học đó hoặc đã bảo lưu học bổng với Quỹ Tempus năm học 2021-2022 nhưng không sang nhập học năm học kế tiếp và không thông báo cho Quỹ Tempus cho đến ngày 31/8 của năm học kế tiếp;

+ Các ứng viên đăng ký học chuyển tiếp nhưng chưa được cấp bằng cho tới ngày 16/01/2023;

+ Các ứng viên đăng ký ngành học mà phía Hung-ga-ri không nhận đào tạo cho ứng viên Việt Nam.

## **2.2. Điều kiện về ngoại ngữ**

- Ứng viên đăng ký học bằng tiếng Hung-ga-ri có chứng chỉ B2 tiếng Hung-ga-ri (theo khung tham chiếu châu Âu) do cơ quan quốc tế có thẩm quyền cấp còn thời hạn sử

dụng (trong vòng 02 năm kể từ ngày cấp chứng chỉ tính đến ngày hết hạn nộp hồ sơ dự tuyển) có thể đăng ký thẳng vào chương trình chuyên ngành;

- Ứng viên đăng ký học bằng tiếng Hung-ga-ri chưa có chứng chỉ B2 tiếng Hung-ga-ri được học 01 năm dự bị tiếng tại Hung-ga-ri. Các ứng viên kết thúc năm học dự bị tiếng đạt yêu cầu đầu vào của các trường đại học Hung-ga-ri sẽ được vào học tiếp chuyên ngành;

- Ứng viên đăng ký học bằng tiếng Hung-ga-ri cần có trình độ tiếng Anh cơ bản;

- Ứng viên đăng ký học bằng tiếng Anh cần có chứng chỉ IELTS 5.5 trở lên hoặc tương đương do cơ quan quốc tế có thẩm quyền cấp còn thời hạn sử dụng (trong vòng 02 năm kể từ ngày cấp chứng chỉ đến ngày hết hạn nộp hồ sơ dự tuyển) hoặc đã tốt nghiệp trình độ đào tạo trước đó ở nước ngoài với ngôn ngữ sử dụng trong khóa học là tiếng Anh.

*Lưu ý:*

- + Ứng viên đăng ký học đại học ngành Luật chỉ được đăng ký học bằng tiếng Hung-ga-ri.

- + Ứng viên đăng ký học thạc sĩ, tiến sĩ ngành Luật có thể đăng ký học bằng tiếng Hung-ga-ri hoặc tiếng Anh.

### **2.3. Đối tượng dự tuyển**

#### **2.3.1. Đối tượng dự tuyển học bổng của Chính phủ Hung-ga-ri**

- Học sinh đang học lớp 12 đã đoạt các giải thưởng quốc gia, quốc tế, khu vực, giải thưởng cấp tỉnh, thành phố trong thời gian học THPT.

- Sinh viên năm thứ nhất của các đại học, học viện, trường đại học.

- Người dự tuyển học bổng thạc sĩ, tiến sĩ cần tốt nghiệp đại học, thạc sĩ đạt loại khá trở lên; ưu tiên ứng viên công tác tại các cơ quan, tổ chức có quan hệ hợp tác với Hung-ga-ri hoặc đã từng học tại Hung-ga-ri.

#### **2.3.2. Đối tượng được xem xét cấp bù học bổng của Chính phủ Việt Nam**

Các ứng viên đủ điều kiện được xét cấp học bổng của Chính phủ Hung-ga-ri sẽ được xem xét cấp thêm học bổng của Chính phủ Việt Nam nếu thuộc các đối tượng dưới đây:

##### *a) Dự tuyển trình độ đại học, thạc sĩ liên thông từ đại học*

- Học sinh đang học lớp 12 đã tham gia đội tuyển quốc gia dự thi Olympic quốc tế và đoạt Huy chương Vàng, Huy chương Bạc, Huy chương Đồng; tham gia kỳ thi chọn học sinh giỏi quốc gia, cuộc thi khoa học, kỹ thuật cấp quốc gia và đoạt các giải: Giải Nhất, Giải Nhì, Giải Ba, thuộc đối tượng được tuyển thẳng vào đại học theo quy chế tuyển sinh đại học.

- Sinh viên năm thứ nhất của các đại học, học viện, trường đại học Việt Nam (hệ chính quy tập trung) thuộc các đối tượng sau: (i) đã đoạt giải tại các kỳ thi Olympic quốc tế và quốc gia thuộc đối tượng được tuyển thẳng vào đại học theo quy chế tuyển sinh đại học; (ii) sinh viên thuộc khối lực lượng vũ trang; (iii) sinh viên là con liệt sĩ; (iv) sinh viên được Ủy ban nhân dân tỉnh, thành phố trực thuộc Trung ương cử dự tuyển, cam kết nhận trở về công tác sau tốt nghiệp.

##### *b) Dự tuyển trình độ thạc sĩ*

- Cán bộ, công chức, viên chức, giảng viên cơ hữu (có hợp đồng và thời gian công tác tối thiểu từ 12 tháng trở lên tính đến ngày 16/01/2023, có đóng bảo hiểm xã hội bắt

buộc), đang công tác tại các cơ quan nhà nước, các cơ sở giáo dục đại học, tốt nghiệp đại học loại khá trở lên.

- Sinh viên tốt nghiệp đại học từ tháng 6 năm 2021 đến hết tháng 12 năm 2022 (đã được cấp bằng và bằng điểm chính thức) với kết quả học tập đạt loại giỏi tại Việt Nam và nước ngoài, trường hợp ứng viên tốt nghiệp tại Hung-ga-ri cần đạt từ 4.0/5.0 trở lên, chưa có quyết định tuyển dụng hoặc hợp đồng làm việc, hợp đồng lao động, có cam kết sau khi hoàn thành khóa học sẽ về nước làm việc theo yêu cầu của Nhà nước, không quá 35 tuổi (tính đến ngày 16/01/2023); ưu tiên đối tượng sinh viên năm tốt do Trung ương Đoàn/Hội sinh viên Việt Nam giới thiệu hoặc được Ủy ban nhân dân tỉnh, thành phố trực thuộc Trung ương cử dự tuyển và cam kết nhận trở về công tác sau tốt nghiệp.

### *c) Dự tuyển trình độ tiến sĩ*

- Cán bộ, công chức, viên chức, giảng viên cơ hữu (có hợp đồng và thời gian công tác tối thiểu từ 12 tháng trở lên tính đến ngày 16/01/2023, có đóng bảo hiểm xã hội bắt buộc), có trình độ thạc sĩ, đang công tác tại các cơ quan nhà nước, các cơ sở giáo dục đại học.

- Học viên tốt nghiệp thạc sĩ từ tháng 6 năm 2021 đến hết tháng 12 năm 2022 (đã được cấp bằng và bằng điểm chính thức) với kết quả học tập đạt loại giỏi tại Việt Nam và nước ngoài, trường hợp ứng viên tốt nghiệp tại Hung-ga-ri cần đạt từ 4.0/5.0 trở lên, chưa có quyết định tuyển dụng hoặc hợp đồng làm việc, hợp đồng lao động, có cam kết sau khi hoàn thành khóa học sẽ về nước làm việc theo yêu cầu của Nhà nước, không quá 35 tuổi (tính đến ngày 16/01/2023).

### **3. Hồ sơ và thời hạn đăng ký dự tuyển:**

Ứng viên dự tuyển cần tiến hành nộp hồ sơ trực tuyến trên cổng thông tin điện tử của Quỹ Tempus và Cục Hợp tác quốc tế, đồng thời nộp hồ sơ giấy bằng tiếng Việt đến Cục Hợp tác quốc tế (xem chi tiết tại các Phụ lục 1, 2, 3, 4 và các thông báo của Quỹ Tempus):

#### **3.1. Nộp hồ sơ trực tuyến (online) tại cổng thông tin điện tử của Quỹ Tempus (<http://www.apply.stipendiumhungaricum.hu>)**

Phía Hung-ga-ri đã mở trang đăng ký trực tuyến bằng tiếng Anh/tiếng Hung-ga-ri cho ứng viên Việt Nam. Thời hạn đăng ký online trên cổng thông tin điện tử phía Hung-ga-ri đến ngày 16/01/2023 (14h00 theo giờ Châu Âu):

Hồ sơ giấy bằng tiếng Anh/tiếng Hung-ga-ri ứng viên tự lưu giữ để mang theo sang Hung-ga-ri nhập học nếu được tiếp nhận và cử đi học.

#### **3.2. Nộp hồ sơ trực tuyến (online) tại cổng thông tin điện tử của Cục Hợp tác quốc tế (<http://tuyensinh.vied.vn>)**

Ứng viên phải quét (scan) lưu lại toàn bộ hồ sơ bằng tiếng Việt sang các files định dạng PDF (mỗi loại tài liệu quét thành 01 file riêng dung lượng không quá 1 MB) để đăng ký trực tuyến. Thời hạn đăng ký online trên cổng thông tin <http://tuyensinh.vied.vn> đến hết ngày 16/01/2023.

#### **3.3. Nộp hồ sơ giấy bằng tiếng Việt**

Hồ sơ cần đựng trong túi hồ sơ kích thước 25cm x 34cm, mặt ngoài ghi đầy đủ thông tin chi tiết theo phụ lục quy định đối với hồ sơ dự tuyển học bổng đi học tại Hung-ga-ri diện Hiệp định năm 2023.

Hồ sơ dự tuyển hợp lệ là hồ sơ có đủ các giấy tờ theo quy định của phía Việt Nam và Hung-ga-ri, được nộp trong thời hạn quy định tại Thông báo tuyển sinh (bao gồm cả hồ sơ online và hồ sơ giấy). Người khai hồ sơ dự tuyển không đúng và người xác nhận sai sẽ bị xử lý theo quy định pháp luật và hủy kết quả tuyển chọn liên quan. Bộ Giáo dục và Đào tạo không trả lại hồ sơ trong bất kỳ trường hợp nào.

Ứng viên chuyển bộ hồ sơ tiếng Việt bằng thư chuyển phát nhanh bảo đảm tới Cục Hợp tác quốc tế - Bộ Giáo dục và Đào tạo, 35 Đại Cồ Việt, Quận Hai Bà Trưng, Hà Nội đến hết ngày 16/01/2023 (tính theo dấu bưu điện và thời gian hoàn thành đăng ký online).

### 3.4. Một số lưu ý khi đăng ký dự tuyển

- Khi đăng ký trực tuyến phía Hung-ga-ri, các ứng viên đã có chứng chỉ tiếng Anh sẽ đăng ký trực tiếp vào chương trình học chuyên ngành tại các trường đại học tại Hung-ga-ri; các ứng viên đăng ký học bằng tiếng Hung-ga-ri sẽ đăng ký vào học chương trình dự bị tiếng Hung-ga-ri (không đăng ký trực tiếp vào chương trình học chuyên ngành);

- Các ứng viên đăng ký học bằng tiếng Anh khi dự tuyển đại học, thạc sĩ liên thông từ đại học và thạc sĩ nếu được tiếp nhận sẽ phải tham gia một khóa học tiếng Hung-ga-ri trong năm thứ nhất và phải trải qua kỳ thi kiểm tra tiếng Hung-ga-ri sau khi kết thúc khóa học. Các ứng viên không tham gia khóa học tiếng Hung-ga-ri sẽ không được phía Hung-ga-ri cấp học bổng. Các ứng viên tham gia khóa học nhưng không đạt yêu cầu trong kỳ thi kiểm tra sẽ chỉ được phía Hung-ga-ri cấp mức sinh hoạt phí thấp hơn mức thông báo chung (xem chi tiết tại thông báo của Quỹ Tempus);

- Ứng viên dự tuyển đại học và thạc sĩ liên thông từ đại học cần lưu ý đăng ký chính xác tên trình độ đào tạo: Đại học (BA) hoặc thạc sĩ liên thông từ đại học (OTM) trong hồ sơ dự tuyển tiếng Việt và trên hệ thống đăng ký trực tuyến phía Hung-ga-ri;

- Tránh sử dụng hòm thư hotmail hoặc yahoo khi đăng ký dự tuyển trực tuyến vì các thư đến dễ bị chuyển vào mục spam.

### 4. Quy trình xét tuyển

- Hội đồng tuyển chọn của Bộ Giáo dục và Đào tạo sẽ xem xét ứng viên dự tuyển có hồ sơ đầy đủ, hợp lệ, nộp đúng hạn theo quy định và căn cứ các tiêu chí tuyển chọn đề sơ tuyển ứng viên;

- Bộ Giáo dục và Đào tạo gửi danh sách các ứng viên được sơ tuyển để đề cử với phía Hung-ga-ri.

- Các ứng viên phải tham gia kiểm tra đầu vào của các trường đại học của Hung-ga-ri. Các ứng viên nhận được thư đồng ý tiếp nhận của một trường đại học tại Hung-ga-ri sẽ được Quỹ Tempus tiếp tục xem xét và quyết định về việc cấp học bổng. Đây là quá trình xét tuyển độc lập của phía Hung-ga-ri, phía Việt Nam không tham gia vào quá trình xét tuyển này.

**Lưu ý:** các ứng viên sẽ được hướng dẫn làm thủ tục xin cấp visa và cử đi học trong tháng 9/2023 khi **đáp ứng đồng thời** các điều kiện sau:

- + Nhận được thư mời học của cơ sở đào tạo tại Hung-ga-ri;
- + Nhận được thư cấp học bổng của Quỹ Tempus;



+ Hồ sơ dự tuyển đáp ứng các yêu cầu của thông báo tuyển sinh này;

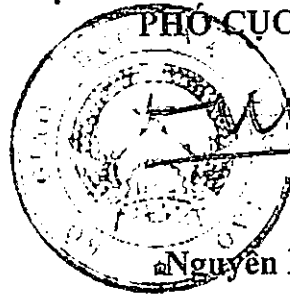
+ Hoàn tất việc chấp nhận học bổng trên hệ thống trực tuyến phía Hung-ga-ri (thời hạn khoảng 2 tuần kể từ khi nhận được email thông báo trúng tuyển của Quỹ Tempus, *xem chi tiết tại Annex 1 for the Operational Regulations*).

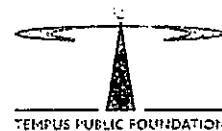

# **1. The Stipendium Hungaricum Scholarship Programme**

## **1.1. Mission of the Programme**

The Stipendium Hungaricum Scholarship Programme was launched in 2013 by the Hungarian Government with the aim of providing opportunity for foreign students to pursue their higher education studies in Hungary. The core mission of the programme is to increase the number of international students in Hungary and to encourage Hungarian higher education institutions to attract top foreign students.

The scholarship programme is managed by the Ministry of Foreign Affairs and Trade, and co-ordinated by Tempus Public Foundation. The programme is based on bilateral educational cooperation agreements signed between the Ministries responsible for education in the sending countries/territories and Hungary. Currently more than 80 Sending Partners are engaged in the programme on 5 different continents, and the geographical scope of the programme is widening each year.

The scholarship program offers both full-degree and partial study opportunities in the three cycle degree structure (bachelor's, master's and doctoral programmes), mostly in English language, however, other foreign language study programmes are also available in the frame of the Stipendium Hungaricum Scholarship Programme. Students can also apply for a one-year Hungarian language preparatory training course, following which they can pursue their higher education studies in Hungarian language.

Stipendium Hungaricum scholarship holders are encouraged to focus on their academic advancement during their stay in Hungary, as all their tuition fees are covered, and their accommodation and living costs are supported as well. Upon finishing their studies, a European degree in hand provides graduates with a wide range of opportunities in the global job market.

Since 2013, the number of Stipendium Hungaricum scholarship holders has grown significantly, at the same time increasing the ratio of self-paying international students in Hungarian universities. Between 2013 and 2019, the ratio of international students studying in Hungarian higher education institutions has doubled, and the ratio of Stipendium Hungaricum scholarship holders among them has quadrupled. As a result, the number of study programmes taught in foreign language(s) has tripled in Hungarian universities since 2015.

The number of both Stipendium Hungaricum applicants and awardees is continuously increasing, as well as the number of available scholarship places. In 2022, more than 50 000 applications were received and nearly 4900 scholarships were awarded, showing that since its launch, the Stipendium Hungaricum scholarship has become a programme of excellence.

## **1.2. Available Scholarship Types**

### **1.2.1. Study Levels**

Stipendium Hungaricum scholarships are available for bachelor's, master's, one-tier master's, doctoral, non-degree programmes (preparatory courses) and postgraduate specialist training courses. Please note that this Call for Application is for bachelor's, master's, one-tier master's, non-degree

programmes and postgraduate specialist training courses only. Please find the Call for Applications for doctoral level here.

**Important note:** applications are only accepted for bachelor's, master's, one-tier master's, non-degree programmes and postgraduate specialist training courses OR for doctoral programmes; therefore please consider carefully your selected programme(s).

**Note about one-tier master's programmes and postgraduate specialist training courses:**

In the Hungarian education system, one-tier master's programmes cover both the bachelor and the master level of studies; therefore, it is an undivided master programme that results in a master degree. These one-tier programmes are offered in specific study fields such as general medicine, pharmacy, dentistry, architecture, law, veterinary surgery, forestry engineering, etc.

Postgraduate specialist training courses provide the opportunity to obtain a specialized qualification after bachelor's or master's degree. Preparatory courses are not available for postgraduate specialist training courses.

### 1.2.2. Study Modes

Both full degree and partial (exchange) study modes are available, in accordance with the relevant bilateral educational cooperation agreement. Full degree programmes are programmes that lead to a bachelor's, master's or doctoral degree. One-year programmes do not lead to a degree but provide a preparatory course before a degree programme.

Partial (exchange) studies are one- or two-semester long exchange studies. If the partial (exchange) studies are part of the student's degree studies in their sending higher education institutions, those who apply for partial (exchange) studies must be registered in and must have a student status at a

higher education institution that operates outside of Hungary. In this case, applicants can only apply to those study levels they are attending in their sending, home institutions (i.e.: doctoral level).

In case partial studies are not part of the student's degree studies in their sending higher education institutions, a student status at a higher education institution that operates outside of Hungary is not needed.

Partial (exchange) studies are available for up to one academic year, must be completed by 30 June and cannot be extended.

Please be **extra cautious** when selecting your preferred study programmes in the online application system as most of the study programmes are offered both as full degree and partial study programmes; therefore, those programmes appear twice. Please make sure that you select the programme marked with the study mode of your desire, because it is not possible to change the study mode after the application deadline.

### 1.3. Provisions Covered by the Scholarship

- **Tuition-free education**
  - exemption from the payment of tuition fee
- **Monthly stipend**
  - **non-degree, bachelor's, master's and one-tier master's level:** monthly amount of HUF 43,700 (cca EUR<sup>2</sup> 103) contribution to the living expenses in Hungary, for 12 months a year, until the completion of studies
- **Accommodation contribution**
  - free dormitory place or a contribution of HUF 40,000/month to accommodation costs for the whole duration of the scholarship period (Please note that if the student does not live in the dormitory, the HUF 40,000/month is a contribution to that rental costs, and in bigger cities – especially in the capital city – this contribution would not cover the full amount of rental costs.)
- **Medical insurance**
  - health care services according to the relevant Hungarian legislation (Act LXXX of 1997, national health insurance card) and supplementary medical insurance for up to HUF 65,000 (cca EUR 153) a year/person

Please bear in mind that these provisions are **only a contribution** to the living expenses of the Scholarship Holders. It means that it **does not fully cover all the costs of living** and the students need to add their own financial resources in order to cover all living expenses in Hungary. ## 2. Eligibility

### 2.1. Eligible Sending Partners

The Stipendium Hungaricum Programme is based on effective bilateral educational cooperation

agreements between the Hungarian Ministry of Foreign Affairs and Trade or its legal predecessor as regards the Stipendium Hungaricum Scholarship Programme, the Ministry of Human Capacities, and the partner's Ministry responsible for higher education. Applications will be considered eligible only if the applicant is nominated by the responsible authorities of the Sending Partner.

Please note that the programme is implemented through direct cooperation with the responsible authorities of the Sending Partner. The application does not have any additional costs, therefore we highly suggest you not to apply through any agencies.

## 2.2. Non-eligibility

Applications will not be considered in the following cases:

- Hungarian citizens (including those with dual citizenships), persons granted a refugee status (“menekült”), persons enjoying temporary protection (“menedékes”), persons admitted for subsidiary protection (“oltalmazott”) and persons granted humanitarian protection (“befogadott”),
  - Please note that this requirement is not only for applicants but for Scholarship Holders as well; it means that, e.g., if you obtain Hungarian citizenship or refugee status during your studies in Hungary, you automatically lose your scholarship status.
- Applicants with a citizenship different from the sending country/territory. For example, only Brazilian citizens can apply through the Brazilian Sending Partner.
- Applicants born after 31 August 2005 (= applicants under 18 years old as of 31 August 2023 except applicants applying for Dance study programmes,
- Applicants applying for a doctoral programme within the SH programme in the same application round
- Those applicants who are registered self-financed / fee-paying students of a Hungarian higher education institution at the time of the application deadline AND who are applying for a study level below their self-financed studies. It means that:
  - self-financed master students of a Hungarian higher education institution cannot apply for bachelor studies, and
- Those former Stipendium Hungaricum Scholarship Holders who were awarded scholarships for full degree studies and who
  - are now re-applying for full degree or partial (exchange) studies in the same cycle or lower level of education (non-degree studies, bachelor, master, one-tire master level) – (therefore, those Stipendium Hungaricum Scholarship Holders can apply for the programme who apply to continue their studies at a higher level of education, e.g. bachelor Scholarship Holders can apply for master studies!)
  - or who are now re-applying for the programme for any cycles of education while they still have a scholarship status at the time of application (unless they withdraw their former scholarship before the application deadline) and will not receive their degree until 31 August 2023
  - or who have postponed the start date of their scholarship studies and did not withdraw their scholarship before the current application deadline.
- Those former Stipendium Hungaricum Scholarship Holders who were awarded scholarships for partial (exchange) studies and who
  - are now re-applying for partial (exchange) studies in the same cycle or lower level of education (non-degree studies, bachelor, master, one-tire master level) – (therefore, those Stipendium Hungaricum Scholarship Holders can apply for a higher level of education, e.g. former bachelor Scholarship Holders can apply for master partial (exchange) studies if they are now master students in their home countries!)
- Those former Stipendium Hungaricum Scholarship Holders who were awarded scholarships in the 2020/21 or in the 2021/22 or in the 2022/23 application round, but after accepting their scholarship, did not travel to Hungary and did not start their studies, nor did they notify Tempus Public Foundation of this fact until 31 August. This clause also applies to those former Stipendium Hungaricum Scholarship Holders who have postponed their scholarship awarded in the 2021/22 application round, but did not travel to Hungary and did not start their studies next year, nor did they notify Tempus Public Foundation of this fact until 31 August.

Please note that it is only possible to re-apply for full degree scholarship studies in the same cycle of education if the former Stipendium Hungaricum Scholarship Holder was previously awarded partial (exchange) studies. Even in this case, the length of the full degree scholarship shall be reduced by the length of the previous partial (exchange) studies.

**Important note for self-financed students already studying in Hungary:**

Those applicants who are **registered self-financed / fee-paying students** of a Hungarian higher education institution at the time of the application deadline **AND** who are now applying for the same study level are only eligible to apply for the Stipendium Hungaricum programme if

- they are recommended by their Hungarian host universities where they are studying at the time of application, AND
- if their cumulative, corrected sum average ("összesített korrigált kreditindex") is higher than the students' average performance in the particular study programme ("szakátlag").

For example, self-financed master students enrolled in Hungary can apply to continue their studies with the scholarship on the same master level only if they are recommended by their university and their cumulative, corrected sum average is above average. Please see further details about the optional application documents in Section 3.2.3. of the Call for Application.

## **2.3. Available Host Institutions and Study Programmes**

At this levels, 28 Hungarian higher education institutions are engaged in the Stipendium Hungaricum Programme for the 2023/2024 academic year with about 650 study programmes in foreign languages (taught mainly in English language). Study programmes are generally available in the English and Hungarian languages, with some programmes offered in German and French as well.

The available study programmes and Host Institutions are accessible in the online application system (<https://apply.stipendiumhungaricum.hu/>).

Please note that you can only apply for these study programmes within the frameworks of the Stipendium Hungaricum Scholarship Programme.

Applicants are eligible to apply only for those scholarship types and study fields that are determined in the educational cooperation programmes in effect between Hungary and the specific Sending Partner. **Please see the full list** of available study fields regarding your sending country here: <https://stipendiumhungaricum.hu/partners/>

## **2.4. Order of Selected Study Programmes**

In addition to the first choice of study programme, there is an opportunity to apply for an additional, second study programme. Therefore, each applicant can apply for **up to TWO different study programmes, in order of preference**. These two study programmes can be both at the same Host Institution and at different Host Institutions; it is the applicants' decision.

The order of preference is essential. During the application process, the first selection and examination process will be conducted for the study programmes selected as the first choices of the applicants. The first priorities will be considered first and then, **only the remaining free places will be filled with those applicants who are not approved for their first choice of programmes**. In this way, the chances of receive the scholarship are relatively higher for the study programmes selected as first choices because there are more free places at that time.

Please note that after the application deadline, the selected programmes (including the study language and the study model) and the order of preference cannot be changed by the applicant! We strongly advise all applicants to carefully check the minimum entry requirements of the study programmes and take time to decide on the order of the two programme preferences. We also highly encourage the applicants to increase their chances of receiving the scholarship by apply for not only one but two study programmes in total.

## 2.5. Language of Study Programmes

Applicants are eligible to apply only if they meet the minimum language criteria set by the chosen Host Institution. Please visit the online application system (<https://apply.stipendiumhungaricum.hu/>) to see the exact language criteria for each study programme!

### Note about language choice in the online application system:

The study programmes are listed as foreign language programmes in the online application system by default. However, if you wish to start your studies at a full degree programme in Hungarian language, you need to answer the "Would you like to perform your studies in Hungarian at the selected full degree programme?" question on the application form with "Yes, I would like to perform my studies in Hungarian at the selected full degree programme." If you select this, you can only be considered for the full degree selected programme in Hungarian language, therefore please be cautious when filling out the online application form. In case you apply for Preparatory course in Hungarian language, please select the following answer: "No, I would not like to study in Hungarian at my full degree programme."

### 2.5.1. Studies in English or Other Foreign Language

Students shall have a level of proficiency in the language of education as required by the Host Institution. The applicants need to directly apply for the study programmes in the online application system.

### 2.5.2. Studies in the Hungarian Language

Those applicants who wish to perform their studies in Hungarian language need to have sufficient language level. A copy of the proof of Hungarian as a foreign language knowledge has to be uploaded as part of the application in the online system. The level of Hungarian language skills will be tested

during institutional entrance examinations. Please note that if you apply only to Hungarian study programmes directly, but fail the language test, you cannot be admitted to any places.

Those applicants whose language skills are not sufficient to complete their studies in Hungarian shall complete an obligatory one-year preparatory language course of Hungarian before starting their degree courses. For this, the applicants are usually required to have at least a basic level of English proficiency. In the online application system, the applicants need to apply directly for the preparatory course (and NOT for the degree programme they wish to start after the language preparatory year). To see all Hungarian language preparatory courses and entry requirements, please check the online application system (<https://apply.stipendiumhungaricum.hu/>)

#### **2.5.6. Hungarian as foreign language**

In the first year of their studies, Scholarship Holders are required to attend the course of „Hungarian as foreign language” offered by the host university, and to pass an exam at the end of the second semester (except Scholarship Holders studying in Hungarian language). Scholarship holders who do not attend the course will not be able to receive the monthly stipend (mentioned at 1.3.). The monthly stipend for students who take the course but fail to pass the exam will be reduced to 30,000 HUF/month.

#### **2.6. Preparatory Courses and foundation semester/year**

Besides full degree programmes, full-time non-degree programmes are also available within the programme in certain cases, for up to one year. **Please read this section if you are applying for study programmes in the field of Music, Engineering or Computer Science and Information Technology.**

Preparatory courses are non-degree programmes before starting a bachelor or master level degree programme at a Host Institution (both with the scholarship).

Regarding the preparatory courses, applicants can ONLY apply for Hungarian language preparatory programmes. Even these preparatory courses can ONLY be applied for if the student wishes to continue his/her degree studies at a Hungarian language programme after the preparatory year. After completion, it is not possible to continue the studies in English or other foreign languages. Please see Section 2.5.2. for further details about this.

However, ONLY in case of English language full degree study programmes in the field of Engineering and Music or Computer Science and Information Technology during the institutional entrance examination process and based on the professional evaluation of the applicant, the Host institutions have the right to make the decision to admit the applicant for a foundation semester/year before they can actually start their full degree programmes. This is only available for a foundation semester/year before bachelor and master level programmes in the field of Engineering, Music or Computer Science and Information Technology. Applicants, therefore, cannot directly apply for foundation semester/year in English language; it is always the Host Institutions' decision if a professional preparation year is necessary or not.

All documents that cannot be obtained or produced in the language of the selected study programme or in Hungarian have to be translated and the translations have to be submitted together with a copy of the original document.

Please note that, in accordance with the General Data Protection Regulation (GDPR) in European Union law, you need to give your consents regarding data protection and accept our Privacy Policy in order to be able to submit your application. These consents appear in the system after registration as well as the Privacy Policy – that is also Statement for Application (sample) Annex 3.

### 3.2.2. Additional Documents for Art and Music Applicants

Beside the documents listed in Section 3.2.1, applicants applying for studies in the field of Arts and/or Music need to upload the following documents as well. All of the following documents are required and need to be submitted via the online application system by **Art and Music applicants** until 16 January 2023, 2 pm.

### 3.2.3. Additional documents for self-financed applicants who wish to continue their studies with the scholarship

Those applicants who are registered self-financed / fee-paying students of a Hungarian higher education institution at the time of the application deadline AND who are now re-applying for the same study level are only eligible to apply for the Stipendium Hungaricum programme in cases listed in Section 2.2. about non-eligibility.

Apart from the requirements about the average performance of the applicant, they need to be recommended by their Hungarian host universities where they are studying at the time of application. Therefore, we recommend all of these applicants to contact their universities and discuss whether the university wishes to recommend them for the scholarship.

In case you are recommended, please ask for a recommendation letter issued by the Hungarian Host Institution. This letter will be uploaded in the online application system by the university.

### 3.3. Missing Documents

All documents listed in Section 3.2. are **mandatory** application documents. However, certain documents are accepted to be uploaded even after the application deadline, **provided that** the applicant could not possibly obtain the document by the deadline of application.

In this case, the applicants need to upload a signed declaration stating that they will obtain and upload the missing document(s) until 1 August 2023 the latest. Please note that there is no form provided by Tempus Public Foundation for the declaration, it can be written by the Applicant. No missing document will be accepted if the declaration is not uploaded until 16 January 2023, 2 pm and/or if the missing documents are not uploaded until 1 August 2023 thus such applications will be rejected automatically.

### 3.4. Submitting the Application

#### 3.4.1. Application to Tempus Public Foundation

All applications shall be submitted through the online application system of Tempus Public Foundation. After registration, the applicants are able to access the application system and upload the required documents. **Applications should be submitted;** only saved applications will not be considered. Please note that no applications will be accepted without the online submission and after the deadline. No hard copies are required. A guide for the online system will be available to download from the [www.stipendiumhungaricum.hu](http://www.stipendiumhungaricum.hu) website.

**All applicants are highly advised to carefully read our Application “Dos and Don’ts” document (please [click here](#) to access) as well as the Privacy Policy (see Statement for Application (sample) Annex 3) that they need to consent to in order to submit the application.**

It is strongly recommended to register with an e-mail address that works properly and that the applicant reads frequently. In case there is a change in the address – including during the study period in Hungary – the host institution and Tempus Public Foundation should be immediately informed and be provided with the new e-mail address by the applicant/scholarship holder. It is always the responsibility of the applicant and the student to manage his/her own email account and to read the letters regularly. Tempus Public Foundation is not responsible for the malfunctioning of the registered e-mail account. Please avoid using for example a Hotmail or a Yahoo account because in that case letters from Tempus Public Foundation usually go to the Spam folder. We strongly advise you not to give your current institutional email address which may change after the start of your scholarship.

The information provided on the application – including the study programmes and their order of preference – cannot be changed after the application deadline. By submitting the application, the applicant declares that all information provided in the online application system of Tempus Public Foundation – including the content of all uploaded documents – are true and correct to the best of their knowledge and belief.

#### 3.4.2. Application to the Sending Partners

All applications shall also be submitted to the responsible authority of the Sending Partner. Each Sending Partner might have different deadlines and requirements for submitting the application

material. Applicants are strongly advised to contact the responsible authority at their Sending Partner as soon as possible and inquire about the exact procedures. For contact details of the responsible authority of the Sending Partner, please visit our website or [click here](#).

The responsible authority of the Sending Partner will review and pre-select the applications. A nomination list, including a reserve list will be forwarded to Tempus Public Foundation by the Sending Partner until the end of February 2023 Applications will be considered only if the applicant is nominated. No other applications will be considered.

### 3.5. Selection Procedure

#### 3.5.1. First Round of Selection: technical check and the nomination of Sending Partner (January-February 2023)

Applications that are only saved in the online system, but not submitted, will be automatically rejected. The applications successfully submitted in Tempus Public Foundation's online application system are checked first. This is called a technical check and it is done by Tempus Public Foundation. During this step, we check the basic eligibility criteria; for example the age, citizenship, the previous scholarships, and check if the applicant has applied for a scholarship type and/or study programme that is available within the framework of the programme and that is available for the applicants of the particular sending country/territory. Also, we will formally check if the required documents are uploaded in the application system or not, and check if the Statement for Application is accepted in the system. However, it is the Host Institution that checks whether the uploaded files and their quality can be accepted and whether these documents meet their entry requirements or not.

Applicants will be automatically rejected during the technical check if they:

- do not successfully submit their application in the online system until 16 January 2023
- are Hungarian citizens, hold a Hungarian dual citizenship or they are persons granted a refugee status, enjoying temporary protection, admitted for subsidiary protection or granted humanitarian protection,
- have a citizenship that is different from the sending country/territory they apply through,
- were born after 31<sup>st</sup> August 2005(except those applying for Dance study programmes),
- have submitted multiple applications
- have submitted applications from more than one account registered to our system
- have submitted multiple applications with more than one sending partner
- do not accept the Statement for Application (please see Annex 2 for sample) in the online system, or they
- are former Stipendium Hungaricum Scholarship Holders or self-finances students at a Hungarian higher education institution in cases described in Section 2.2. about non-eligibility.
- were awarded the Stipendium Hungaricum scholarship for the 2020/21 or for the 2021/22 or for the 2022/23 academic year, but after accepting their scholarship, did not travel to Hungary and did not start their studies, nor did they notify Tempus Public Foundation of this fact until 31 August
- have postponed their scholarship awarded in the 2021/22 application round, but did not travel to Hungary and did not start their studies next year, nor did they notify Tempus Public Foundation of this fact until 31 August
- provided any false information during the application process

These eligible and successfully submitted applications are forwarded to the responsible authorities of the Sending Partners for review and pre-selection. The exact methods and guidelines of the Sending Partners' selection are determined by the Sending Partners. After the selection decision of the Sending Partner, a nomination list, including a reserve list will be issued and forwarded to Tempus Public Foundation by the Sending Partner until 28 February 2023

**Applicants can only apply through sending countries/territories of their own nationality. Sending Partners can only nominate applicants with the same citizenship. Only nominated applicants will be considered for the second round of selection: the institutional evaluation.**

### 3.5.2. Second Round of Selection: the institutional evaluation (March- May 2023)

The application materials of the nominated applicants (including the reserve list) are forwarded to the Host Institutions for professional evaluation. The institutions will also run a formal check first to see if all the documents submitted by the applicants meet the requirements of the Call for Applications and the minimum entry requirements of the selected study programme(s).

Applicants with a valid, formally correct application that meet the minimum entry requirements can proceed to the institutional entrance examinations. Each applicant can participate in up to two institutional entrance examinations – in accordance with their submitted applications.

The exact date and method of the entrance examination vary by institutions. **Each applicant will be individually informed about further details (e.g., date of examination) directly by their selected Host Institution(s).**

As applicants can apply for up to two study programmes, **institutional examinations are conducted in two rounds.**

1. Applications for the **first selected study programmes** are considered first by the universities. The examination process for the first selected programmes can be expected between 18 March and 30 April 2023 however, the dates are indicative.
2. Applications for the **second selected study programmes** are considered afterwards. The examination process for the second selected programmes can be expected between 18 March and 20 May 2023 however, the dates are indicative.

Depending on the selected Host Institutions' schedule of examinations, it is possible that there will be no entrance examinations for the second study programme selected by the applicant – in case the applicant is already approved for the scholarship for the first selected study programme.

**Note for applicants for Medical programmes:** the field of Medical studies is one of the most competitive study fields in the Stipendium Hungaricum Programme due to the very high number of applications and the limited number of scholarship places. As a result, most of the Host Institutions are expected to fill all their medical scholarship places during the examination of those who applied for their programme as a first choice. As a consequence, applicants for Medical programmes can expect that the Host Institutions will not consider them if the programme is selected only as a second choice.

The applicants are evaluated on a 100 point scale. The final examination results and the examination points given by the Host Institutions are then forwarded to Tempus Public Foundation.

**Important note: the required minimum to be achieved is 56 points (on a 100 point scale). No applicants shall receive a scholarship offer with an examination result below 56 points.**

### 3.5.3. Allocation of Admitted Applicants (May-June 2023)

Tempus Public Foundation is responsible for the allocation of the applicants. In case of all countries participating in the programme, the allocation of the applicants and the selection of Scholarship Holders depend of the allocation principles described in the Operational Regulations (see **Annex 1**) of the programme. In general, the principles the decision is made by are the following:

1. the content of the relevant bilateral agreement in effect between Hungary and the Sending Partner,

2. the capacity (minimum and maximum number of available places) of the university's specific study programme (you can check it in the online application system: <https://apply.stipendiumhungaricum.hu/>),
3. the preference order of the selected study programmes on the application form (please read Section 2.4 carefully),
4. the examination results (100 points maximum) given by the Host Institutions and the points based on the ranking order of the Sending Partners' nomination lists

Apart from these, in order to support student diversity, the number of eligible applicants from the same country may be limited in case of certain study programmes due to the limited number of places offered in the Stipendium Hungaricum programme (e.g. medical programmes).

Applicants can receive one of the following statuses:

- approved Scholarship Holder, or
- conditionally approved Scholarship Holder (in case any missing documents need to be uploaded), or
- approved on waiting list (can only be approved if Scholarship Holders withdraw), or
- rejected.

The application of a person identified by the competent national security services as a potential risk, can be rejected by the Board of Trustees of the Tempus Public Foundation.

The applicants will be informed about the application results around the end of June 2023 (please see timeline at Section 3.4.3). Please note that applicants can expect only one information email from Tempus Public Foundation about the results. Depending on the allocation results, applicants can expect this letter anytime throughout June and July; therefore, we would like to ask for your patience. Please note that we are not able to reply to individual requests asking for the results and all applicants will be informed via the online system.

### **3.6. Acceptance of the Scholarship**

Those who do not accept their scholarship until the deadlines below are automatically considered withdrawn from the scholarship.

Applicants who are awarded the scholarship shall not receive Scholarship Holder status if they:

- withdraw from the scholarship in writing (sent to both Tempus Public Foundation and the Host Institution) or via the application system, or
- fail to upload their missing application documents until 1 August 2023 or
- fail to accept their scholarship until the given deadline, or
- do not hold a secondary school graduation certificate until 1 August 2023 or
- withdraw their data protection (GDPR) consents, or
- provide false information during the application process.

#### **3.6.1. Acceptance of Scholarship for Approved Scholarship Holders**

In order to gain a Scholarship Holder status, approved applicants must accept their scholarship and consent to the Operational Regulations of the programme (see Annex 1 for the Operational Regulations) in the online application system within the time frame written in the notification e-mail

(usually this is within two weeks after receiving the notification e-mail about the application decision, but it can be a shorter period) **but no later than 1 August 2023.**

### **3.6.2. Acceptance of Scholarship for Conditionally Approved Scholarship Holders**

If the applicant is conditionally approved because they have any missing documents that could be uploaded after the application deadline, all these missing documents need to be uploaded via the online system immediately after receiving all documents (and after receiving the notification about the conditional status), and no later than 1 August 2023. Please see details in Section 3.3. about missing documents.

Conditionally approved Scholarship Holders must accept their scholarship and consent to the Operational Regulations of the programme (see Annex 1 for the Operational Regulations) in the online application system within the time frame written in the notification e-mail (usually this is within two weeks after receiving the notification e-mail about the application decision, but it can be a shorter period) **but no later than 1 August 2023.**

## **4. Studying in Hungary**

Any possible changes in the entry and enrolment system due to the COVID-19 pandemic situation will be posted on our website: <https://stipendiumhungaricum.hu/>. Please consult the website regularly.

### **4.1. Visa Applications**

You are requested to **start your visa application process immediately** after receiving the positive decision about the scholarship. Officially, it may take 30 days until a visa is issued. In order to apply for visa to Hungary, you need to contact the competent consular office. For more information please contact the website of the Hungarian Ministry of Foreign Affairs and Trade (<https://konzinfo.mfa.gov.hu/en> and the Directorate-General for Aliens Policing (<http://oif.gov.hu/index.php?lang=en>

Please note that the citizens of some countries do not need a visa to enter Hungary due to the Visa Waiver Agreements. At the time of writing, these countries include: Albania, Argentina, Brazil, Bosnia and Herzegovina, Chile, Costa Rica, Colombia, Georgia, Israel, Japan, Malaysia, Marshall Islands, Mexico, Moldova, Montenegro, North Macedonia, Panama, Peru, Republic of Korea, Saint Lucia, Serbia, Seychelles, Singapore, Taiwan, Ukraine, United Arab Emirates and Uruguay – as well as the passport of the special administrative territory of Hong Kong and Macao.

Please make sure to visit the Consular Services website for up-to-date information about your country: <https://konzinfo.mfa.gov.hu/en/visa-free-travel-hungary>

Please note that the Scholarship Holder status does not automatically guarantee a visa.

### **4.2. Arrival and Enrolment**

We highly recommend all applicants to visit our Study in Hungary website ([www.studyinhungary.hu](http://www.studyinhungary.hu)) for detailed information about life and education in Hungary. As mentioned in Section 1.3, please also check the expected living expenses with our [Cost of Living Calculator](#).



Scholarship Holders are required to inform the Stipendium Hungaricum coordinator of their Host Institution (please see contact details on our website) about their expected date of arrival 30 – but not less than 15 – days before arrival.

Successful applicants are expected to make their own travel arrangements to Hungary – no financial provisions will be provided for travel expenses by the Hungarian side. In accordance with current legislations, Scholarship Holders are entitled to be exempt from the payment of any fees related to their admission to Hungary. No visa, administrative services or additional contribution is given to family members or accompanying persons.

Please note that the Stipendium Hungaricum Scholarship Programme does not fully cover all upcoming costs of the Scholarship Holder. It means that the students need to add their own financial resources in order to cover all living expenses in Hungary. All applicants are highly advised to check the expected living expenses both in Hungary and in the city that they wish to live in before applying; please do check our Cost of Living Calculator by clicking here: <http://www.studyinhungary.hu/living-in-hungary/menu/your-costs-of-living.html>

Scholarship Holders are expected to obtain their visa, arrive in Hungary and **register at the Host Institution no later than 30 September 2023** (for study programmes starting in the Autumn Semester) – or the date set by the Host Institutions. The applicant who is granted the scholarship must enrol to the Host Institution in the semester in which she/he was granted admission.

In principle, it is **not possible to postpone the start of the scholarship studies** to another semester or academic year – except for very special, unforeseeable, force majeure cases described in the Operational Regulations, with the special approval of Tempus Public Foundation. Therefore, in principle if the Scholarship Holder does not enrol until 30 September 2023 or the date set by the Host Institutions, she/he will be automatically excluded from the scholarship programme.

Please note that Scholarship holders will take part in medical examinations organized by universities upon their arrival (it is free of charge for Scholarship Holders).

### 4.3. Rights and Obligations

#### 4.3.1. Operational Regulations, GDPR and Student Contract

All Scholarship Holders are bound by the Operational Regulations of the Stipendium Hungaricum Programme. Please make sure to read it carefully in Annex 1. The following text contains extracts from the Operational Regulations; however, all Scholarship Holders must read the full text of the regulations.

Scholarship Holders are required to sign a scholarship contract with the Host Institution including study-related details and the rights and obligations of the Scholarship Holders (see sample [on our website](#) or at the end of the Operational Regulations).

The Stipendium Hungaricum scholarship is a contribution to the living costs of the Scholarship Holder only, therefore – within the framework of the programme – visa-related assistance, additional allowance and administrative services are not provided for any accompanying people or family

**members. The legal entity of the scholarship contract is exclusively the Scholarship Holder and the Host Institution.**

The Scholarship Holders are expected to follow the regulations of the Host Institution and continue their studies in good faith, to the best of their abilities, in order to meet the academic requirements of the study programme and thus finish the programme successfully. By accepting the scholarship, the Scholarship Holders agree to participate in the alumni system of the programme that supports the maintenance of relationships with the Scholarship Holders and facilitates the flow of information – such as the alumni website, alumni events and surveys about the satisfaction of students, career monitoring, and the evaluation of research activities.

Please note that the Scholarship Holder students generally complete 30 credits in a semester; therefore, we suggest to register courses with at least 30 credits in total. Please also note that if the Scholarship Holder does not complete at least 18 credits on the average during the last two semesters with an active student status (in total 36 credits), their scholarship status shall be terminated.

Please note that the Operational Regulations of the Stipendium Hungaricum Programme can be subject to change, and the Scholarship Holders are always bound by the prevailing regulations at any given time.

Please note that, in accordance with the General Data Protection Regulation (GDPR) in European Union law, all applicants need to give consents regarding data protection and accept the Privacy Policy (see Annex 3) in order to be able to submit an application. These consents appear in the online application system after registration.

#### **4.3.2. Staying in Hungary**

**Scholarship Holders are obliged to live and study in Hungary; therefore, they are not allowed to live habitually in any other country during the study period, otherwise their scholarship holder status will be terminated.**

#### **4.3.3. Other Scholarships and Double Financing**

As the Stipendium Hungaricum scholarship covers the entire period of the studies, the Scholarship Holders are not entitled to use financial support for getting enrolled in full time or partial (exchange) study programmes outside Hungary (e.g. Erasmus +, CEEPUS, Campus Mundi). They can only participate in conferences or research activities that are professionally relevant for their studies. These activities should not exceed 14 days or in any way prevent the student from habitually living in Hungary.

Applicants are also not eligible to receive the Stipendium Hungaricum scholarship in case they have another concurrent scholarship from the Hungarian central budget for studies in Hungary. If the Scholarship Holder was awarded more than one scholarship, she/he has to choose one of the scholarships and withdraw from the other ones. However, the Host Institutions are allowed to provide additional financial support for the students on a social, performance-related, or other basis.

In accordance with the regulations of Government Decree 51/2007. (III. 26.), Scholarship Holders are entitled to be awarded with the National Higher Education Scholarship ("nemzeti felsőoktatási ösztöndíj")

#### 4.3.4. Termination of Scholarship Status

The details and cases when the scholarship status is terminated are listed in the Operational Regulations of the programme (see Section IV. of **Annex 1**). It is important to highlight that– after the consultation with Tempus Public Foundation and in case the university does not have other interior regulations about this – the Host Institution has the right to terminate the scholarship status of the student **if the students does not complete at least 18 credits on the average during the last two semesters** (in total 36 credits) when she/he had an active student status.

In accordance with the Operational Regulations of the programme, the scholarship status is terminated if

- the student status of the Scholarship Holder is terminated by the Host Institution,
- the Scholarship Holder does not complete at least 18 credits on the average during the last two semesters with an active student status,
- the Scholarship Holder withdraws from the scholarship in writing (sent to both Tempus Public Foundation and the Host Institution),
- after accepting his/her scholarship, the scholarship holder does not travel to Hungary and does not start his/her studies (if he/she does not notify Tempus Public Foundation of this fact, he/she cannot apply in the next 3 years) Holder had obtained their degrees (or completed their non-degree studies) at the study programme supported by the scholarship,
- the scholarship holders have used up all their awarded scholarship semesters and had not submitted an extension request; or if they are not entitled for extension,
- the Scholarship Holder does not fulfil their obligation to participate in medical screenings, and their additional obligations set out in the healthcare protocol, or he is deemed unfit during the obligatory medical examination,
- the Scholarship Holder does not comply with the regulations of the programme regarding the obligation of living habitually in Hungary,
- the Scholarship Holder receives Hungarian citizenship (including those with dual citizenships), is granted refugee status (“menekült”), temporary protection (“menedékes”), or admitted for subsidiary protection (“oltalmazott”) or granted humanitarian protection (“befogadott”),
- as a result of institutional disciplinary or criminal proceedings against the scholarship holder, the scholarship holder is expelled, and for this reason the Public Foundation asks the host institution to terminate the scholarship status,
- in other cases described in the Operational Regulations of the programme in effect.

# 1. The Stipendium Hungaricum Scholarship Programme

## 1.1. Mission of the Programme

The Stipendium Hungaricum Scholarship Programme was launched in 2013 by the Hungarian Government with the aim of providing opportunity for foreign students to pursue their higher education studies in Hungary. The core mission of the programme is to increase the number of international students in Hungary and to encourage Hungarian higher education institutions to attract top foreign students.

The scholarship programme is managed by the Ministry of Foreign Affairs and Trade, and co-ordinated by Tempus Public Foundation. The programme is based on bilateral educational cooperation agreements signed between the Ministries responsible for education in the sending countries/territories and Hungary. Currently more than 80 Sending Partners are engaged in the programme on 5 different continents, and the geographical scope of the programme is widening each year.

The scholarship program offers both full-degree and partial study opportunities in the three cycle degree structure (bachelor's, master's and doctoral programmes), mostly in English language, however, other foreign language study programmes are also available in the frame of the Stipendium Hungaricum Scholarship Programme. Students can also apply for a one-year Hungarian language preparatory training course, following which they can pursue their higher education studies in Hungarian language.

Stipendium Hungaricum scholarship holders are encouraged to focus on their academic advancement during their stay in Hungary, as all their tuition fees are covered, and their accommodation and living costs are supported as well. Upon finishing their studies, a European degree in hand provides graduates with a wide range of opportunities in the global job market.

Since 2013, the number of Stipendium Hungaricum scholarship holders has grown significantly, at the same time increasing the ratio of self-paying international students in Hungarian universities. Between 2013 and 2019, the ratio of international students studying in Hungarian higher education institutions has doubled, and the ratio of Stipendium Hungaricum scholarship holders among them has quadrupled. As a result, the number of study programmes taught in foreign language(s) has tripled in Hungarian universities since 2015.

The number of both Stipendium Hungaricum applicants and awardees is continuously increasing, as well as the number of available scholarship places. In 2022, more than 50 000 applications were received and nearly 4900 scholarships were awarded, showing that since its launch, the Stipendium Hungaricum scholarship has become a programme of excellence.

## 1.2. Available Scholarship Types

### 1.2.1. Study Levels

Stipendium Hungaricum scholarships are available for bachelor's, master's, one-tier master's, doctoral, non-degree programmes (preparatory courses) and postgraduate specialist training courses. **Please note that this Call for Application is for doctoral programmes only.** Please find here the Call for

**Important note:** applications are only accepted for bachelor's, master's, one-tier master's, non-degree programmes and postgraduate specialist training courses OR for doctoral programmes; therefore please consider carefully your selected programme(s).

#### **Note about doctoral programmes:**

In Hungary, the duration of doctoral programmes is 8 semesters. Doctoral programmes are divided into two different phases: the first phase (4 semesters) is for professional training and research, while the second phase (4 semesters) is for research and dissertation. At the end of the first 4 semesters, doctoral students are obliged to take a complex exam, where the educational and research progress of the student is evaluated. Doctoral students can only continue with the second phase of their studies upon the successful completion of the complex exam. The amount of the monthly stipend is different in the two phases of doctoral programmes. Please see section 1.3 about financial details and section 3.1. about the details of application for doctoral programmes.

#### **1.2.2. Study Modes**

Both full degree and partial (exchange) study modes are available, in accordance with the relevant bilateral educational cooperation agreement. Full degree programmes are programmes that lead to a doctoral degree.

Partial (exchange) studies are one- or two-semester long exchange studies. If the partial (exchange) studies are part of the student's degree studies in their sending higher education institutions, those who apply for partial (exchange) studies must be registered in and must have a student status at a higher education institution that operates outside of Hungary. In this case, applicants can only apply to those study levels they are attending in their sending, home institutions (i.e.: doctoral level).

In case partial studies are not part of the student's degree studies in their sending higher education institutions, a student status at a higher education institution that operates outside of Hungary is not needed.

Partial (exchange) studies are available for up to one academic year, must be completed by 30 June and cannot be extended.

Please be extra cautious when selecting your preferred study programmes in the online application system as most of the study programmes are offered both as full degree and partial study programmes; therefore, those programmes appear twice. Please make sure that you select the programme marked with the study mode of your desire, because it is not possible to change the study mode after the application deadline.

### 1.3. Provisions Covered by the Scholarship

- **Tuition-free education**
  - exemption from the payment of tuition fee
- **Monthly stipend**
  - **doctoral level:** according to the current Hungarian legislation, the monthly amount of scholarship is HUF 140,000 (cca EUR<sup>1</sup> 331 for the first phase of education (4 semesters) and HUF 180,000 (cca EUR 425) for the second phase (4 semesters) - for 12 months a year, until completion of studies. Please see details in section 1.2.1.
- **Accommodation contribution**
  - free dormitory place or a contribution of HUF 40,000/month to accommodation costs for the whole duration of the scholarship period (Please note that if the student does not live in the dormitory, then the HUF 40,000/month is a contribution to that rental costs, and in bigger cities – especially in the capital city – this contribution would not cover the full amount of rental costs.)
- **Medical insurance**
  - health care services according to the relevant Hungarian legislation (Act LXXX of 1997, national health insurance card) and supplementary medical insurance for up to HUF 65,000 (cca EUR 153) a year/person

Please bear in mind that these provisions are **only a contribution** to the living expenses of the Scholarship Holders. It means that it **does not fully cover all the costs of living** and the students need to add their own financial resources in order to cover all living expenses in Hungary. All applicants are highly advised to check the expected living expenses both in Hungary and in the city that they wish to live in before applying; please do check our Cost of Living Calculator by clicking here: <http://www.studyinhungary.hu/living-in-hungary/menu/your-costs-of-living.html>

## 2. Eligibility

### 2.1. Eligible Sending Partners

The Stipendium Hungaricum Programme is based on effective bilateral educational cooperation agreements between the Hungarian Ministry of Foreign Affairs and Trade or its legal predecessor as regards the Stipendium Hungaricum Scholarship Programme, the Ministry of Human Capacities, and the partner's Ministry responsible for higher education. Applications will be considered eligible only if the applicant is nominated by the responsible authorities of the Sending Partner.

Please note that the programme is implemented through direct cooperation with the responsible authorities of the Sending Partner. The application does not have any additional costs, therefore we highly suggest you not to apply through any agencies.

## 2.2. Non-eligibility

**Applications will not be considered in the following cases:**

- Hungarian citizens (including those with dual citizenships), persons granted a refugee status ("menekült), persons enjoying temporary protection ("menedékes"), persons admitted for subsidiary protection ("oltalmazott") and persons granted humanitarian protection ("befogadott"),
  - Please note that this requirement is not only for applicants but for Scholarship Holders as well; it means that, e.g., if you obtain a Hungarian citizenship or a refugee status during your studies in Hungary, you automatically lose your scholarship status.
- Applicants with a citizenship different from the sending country/territory. For example, only Brazilian citizens can apply through the Brazilian Sending Partner.
- Applicants applying for bachelor's, master's, one-tier master's and non-degree programmes within the SH programme in the same application round

- Those former Stipendium Hungaricum Scholarship Holders who were awarded scholarships for full degree studies and who
  - are now re-applying for full degree or partial (exchange) studies in the same cycle of education (doctoral level) – (therefore, those Stipendium Hungaricum Scholarship Holders can apply for the programme who apply to continue their studies at a different cycle of education, e.g. master's student Scholarship Holders can apply for doctoral studies!)
  - or who are now re-applying for the programme for any cycles of education while they still have a scholarship status at the time of application (unless they withdraw their former scholarship before the application deadline) and will not receive their degree until 31 August 2023
  - or who have postponed the start date of their scholarship studies and did not withdraw their scholarship before the current application deadline.
- Those former Stipendium Hungaricum Scholarship Holders who were awarded scholarships for partial (exchange) studies and who
  - are now re-applying for partial (exchange) studies in the same cycle of education (doctoral level) – (therefore, those Stipendium Hungaricum Scholarship Holders can apply for a different cycle of education, e.g. former master's student Scholarship Holders can apply for doctoral partial (exchange) studies if they are now doctoral students in their home countries).
- Those former Stipendium Hungaricum Scholarship Holders who were awarded the scholarship in the 2020/21 or in the 2021/22 or in the 2022/23 application round, but after accepting their scholarship, did not travel to Hungary and did not start their studies, nor did they notify Tempus Public Foundation of this fact until 31 August. This clause also applies to those former Stipendium Hungaricum Scholarship Holders who have postponed their scholarship awarded in the 2021/22 application round, but did not travel to Hungary and did not start their studies next year, nor did they notify Tempus Public Foundation of this fact until 31 August.

Please note that it is only possible to re-apply for full degree scholarship studies in the same cycle of education if the former Stipendium Hungaricum Scholarship Holder was previously awarded scholarship for partial (exchange) studies. Even in this case, the length of the full degree scholarship shall be reduced by the length of the previous partial (exchange) studies.

**Important note for self-financed students already studying in Hungary:**

Those applicants who are **registered self-financed / fee-paying students** of a Hungarian higher education institution at the time of the application deadline AND who are now applying for the same study level are only eligible to apply for the Stipendium Hungaricum programme if they are recommended by their Hungarian host universities where they are studying at the time of application.

Based on the above, self-financed PhD students enrolled in Hungary can apply to continue their studies with the scholarship only if they are recommended by their university. Please see further details about the optional application documents in Section 3.2.3. of the Call for Application.

## 2.3. Supervisor

Some doctoral schools request students applying for their doctoral programmes to have a supervisor at the Host Institution, who, in the case of the successful application process, will undertake the supervising of the student's doctoral education and research activities within the frameworks of the doctoral programme chosen by the applicant. In case it is required by the doctoral programme you are

applying for, a statement of acceptance issued by the supervisor must be attached to the application. **Please make sure whether the doctoral programme you are applying for requires a statement of acceptance.**

## 2.4. Available Host Institutions and Study Programmes

At doctoral level, 21 Hungarian higher education institutions are engaged in the Stipendium Hungaricum Programme for the 2023/2024 academic year, with more than 150 study programmes, taught mainly in English; further programmes taught in Hungarian are also available for applicants with suitable proficiency.

The available study programmes and Host Institutions are available in the online application system (<https://apply.stipendiumhungaricum.hu/>). Please note that you can only apply for these study programmes within the frameworks of the Stipendium Hungaricum Scholarship Programme.

Applicants are eligible to apply only for those scholarship types and study fields that are determined in the educational cooperation programmes in effect between Hungary and the specific Sending Partner. **Please see the full list of available study fields regarding your sending country here:** <https://stipendiumhungaricum.hu/partners/>.

## 2.5. Order of Selected Study Programmes

In addition to the first choice of study programme, there is an opportunity to apply for an additional, second study programme. Therefore, each applicant can apply for **up to TWO different study programmes, in order of preference**. These two study programmes can be both at the same Host Institution and at different Host Institutions; it is the applicants' decision.

The order of preference is essential. During the application process, the first selection and examination process will be conducted for the study programmes selected as the first choices of the applicants. The first priorities will be considered first and then, **only the remaining free places will be filled with those applicants who are not approved for their first choice of programmes**. In this way, the chances of receive the scholarship are relatively higher for the study programmes selected as first choices because there are more free places at that time.

Please note that after the application deadline., the selected programmes (including the study language and the study mode!) and the order of preference cannot be changed by the applicant! We strongly advise all applicants to carefully check the minimum entry requirements of the study programmes and take time to decide on the order of the two programme preferences. We also highly encourage the applicants to increase their chances of receiving the scholarship by apply for not only one but two study programmes in total.

## 2.6. Language of Study Programmes

Applicants are eligible to apply only if they meet the minimum language criteria set by their chosen Host Institution. Please visit the online application system (<https://apply.stipendiumhungaricum.hu/>) to see the exact language criteria for each study programme.

**Note about language choice in the online application system:**

The study programmes are listed as foreign language programmes in the online application system by default. However, if you wish to start your studies at a full degree programme in Hungarian language, you need to answer the “Would you like to perform your studies in Hungarian at the selected full degree programme?” question on the application form with “Yes, I would like to perform my studies in Hungarian at the selected full degree programme..” If you select this, you can only be considered for the full degree selected programme in Hungarian language, therefore please be cautious when filling out the online application form. In case you apply for Preparatory course in Hungarian language, please select the following answer: “No, I would not like to study in Hungarian at my full degree programme.”

### 2.6.1. Studies in English or Other Foreign Language

Students shall have a level of proficiency in the language of education as required by the Host Institution. The applicants need to directly apply for the study programmes in the online application system.

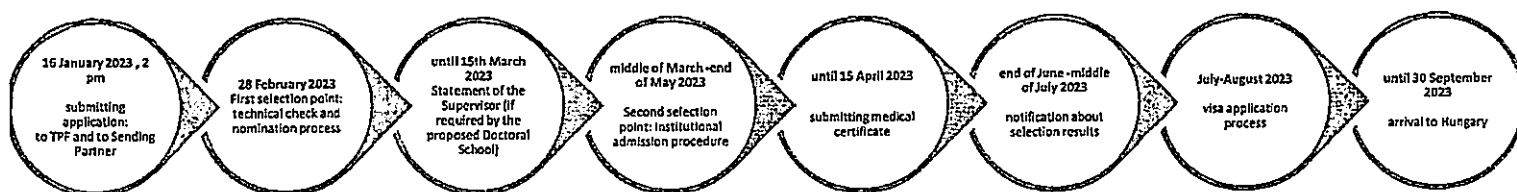
### 2.6.2. Studies in the Hungarian Language

Those applicants who wish to perform their studies in Hungarian language need to have sufficient language level. A copy of the proof of Hungarian as a foreign language knowledge has to be uploaded as part of the application in the online system. The level of Hungarian language skills will be tested during institutional entrance examinations. Please note that if you apply only to Hungarian study programmes directly, but fail the language test, you cannot be admitted to any places.

Those applicants whose language skills are not sufficient to complete their studies in Hungarian shall complete an obligatory one-year preparatory language course of Hungarian before starting their degree courses. For this, the applicants are usually required to have at least a basic level of English proficiency. In the online application system, the applicants need to apply directly for the preparatory course (and NOT for the degree programme they wish to start after the language preparatory year). - See Section 3.3. for the list of application documents that may be uploaded after the application deadline too.

##### 3.2.1. Basic Application Documents

All of the following documents are compulsory and need to be submitted to the online application system by all applicants until 16 January 2023, 2 pm, except for the Statement of the Supervisor (if required by the proposed Doctoral School, see section 2.3.) which must be submitted until 15 March 2023 and the medical certificate which must be submitted by the nominated applicants only until 15 April.

If applicants can not upload the statement of supervisor until 31 January 2023, they are required to upload a declaration to the relevant task directly. In the statement applicants need to declare that they will upload the statement of supervisor until 15 March 2023.

Please note that only files with a maximum size of 4 MB can be uploaded in the system.

All documents that cannot be obtained or produced in the language of the selected study programme or in Hungarian have to be translated and the translations have to be submitted together with a the copy of the original document.

Please note that in accordance with the General Data Protection Regulation (GDPR) in European Union law, you need to give your consents regarding data protection and accept our Privacy Policy in order to be able to submit your application. These consents appear in the system after registration as well as the Privacy Policy – that is also Statement for Application (sample) Annex 3.

All applicants of doctoral programmes are required to visit <http://www.doktori.hu> before they submit their application. The website provides information about the Hungarian doctoral schools, available research fields and research topics as well as the possible supervisors of doctoral students in English and Hungarian language. Proposed research topics for aspiring doctoral students are available at <http://www.doktori.hu/index.php?menuid=115&lang=EN>.

Doctoral applicants are also required to contact their chosen Host Institutions and doctoral schools in advance in order to discuss the available research topics in the institution as well as the possible supervisors for those topics. All students applying for a doctoral programme must have a supervisor at their selected Host University. The list of Stipendium Hungaricum coordinators at the Host Institutions is available at <https://stipendiumhungaricum.hu/study-finder/>. These pieces of information need to be considered when preparing the application materials (e.g. research plan) and whilst choosing a doctoral programme and research area.

### 3.2.2. Additional Documents for Art Applicants

Besides the documents listed in Section 3.2.1, applicants applying for studies in the field of Arts need to upload the following documents as well. All of the following documents are required and need to be submitted via the online application system by **Art applicants** until 16 January 2023, 2pm.

Please note that only files with a maximum size of 4 MB can be uploaded in the system. If the size of the portfolio is larger than 4 MB, please upload a document that contains the link(s) where the portfolio file(s) can be downloaded from.

### 3.2.3. Additional documents for self-financed applicants who wish to continue their studies with the scholarship

Those applicants who are registered self-financed / fee-paying students of a Hungarian higher education institution at the time of the application deadline AND who are now re-applying for the same study level are only eligible to apply for the Stipendium Hungaricum programme in cases listed in Section 2.2. about non-eligibility.

Apart from the requirements about the average performance of the applicant, they need to be recommended by their Hungarian host universities where they are studying at the time of application. Therefore, we recommend all of these applicants to contact their universities and discuss whether the university wishes to recommend them for the scholarship.

In case you are recommended, please ask for a recommendation letter issued by the Hungarian Host Institution. This letter will be uploaded in the online application system by the university.

### 3.3. Missing Documents

All documents listed in Section 3.2. are **mandatory** application documents. However, certain documents are accepted to be uploaded even after the application deadline, **provided that** the applicant could not possibly obtain the document by the deadline of application.

In this case, the applicants need to upload a signed declaration stating that they will obtain and upload the missing document(s) until 1 August 2023 the latest. Please note that there is no form provided by Tempus Public Foundation for the declaration, it can be written by the Applicant. No missing document will be accepted if the declaration is not uploaded until 15 January 2023, 2 pm and/or if the missing documents are not uploaded until 1 August 2023, thus such applications will be rejected automatically.

### 3.4. Submitting the Application

#### 3.4.1. Application to Tempus Public Foundation

All applications shall be submitted through the online application system of Tempus Public Foundation. After registration, the applicants are able to access the application system and upload the required documents. **Applications should be submitted;** only saved applications will not be considered. Please note that no applications will be accepted without the online submission and after the deadline. No hard copies are required. A guide for the online system will be available to download from the [www.stipendiumhungaricum.hu](http://www.stipendiumhungaricum.hu) website.

All applicants are highly advised to carefully read our Application "Dos and Don'ts" document (please [click here](#) to access) as well as the Privacy Policy (see Statement for Application (sample) Annex 3) that they need to consent to in order to submit the application.

It is strongly recommended to register with an e-mail address that works properly and that the applicant reads frequently. In case there is a change in the address – including during the study period in Hungary – the host institution and Tempus Public Foundation should be immediately informed and be provided with the new e-mail address by the applicant/scholarship holder. It is always the responsibility of the applicant and the student to manage his/her own email account and to read the letters regularly. Tempus Public Foundation is not responsible for the malfunctioning of the registered e-mail account. Please avoid using for example a Hotmail or a Yahoo account because in that case letters from Tempus Public Foundation usually go to the Spam folder.

The information provided on the application – including the study programmes and their order of preference – cannot be changed after the application deadline. By submitting the application, the applicant declares that all information provided in the online application system of Tempus Public

Foundation – including the content of all uploaded documents – are true and correct to the best of their knowledge and belief.

#### **3.4.2. Application to the Sending Partners**

All applications shall also be submitted to the responsible authority of the Sending Partner. Each Sending Partner might have different deadlines and requirements for submitting the application material. **Applicants are strongly advised to contact the responsible authority at their Sending Partner as soon as possible and inquire about the exact procedures.** For contact details of the responsible authority of the Sending Partner, please visit our website or [click here](#).

The responsible authority of the Sending Partner will review and pre-select the applications. A nomination list, including a reserve list will be forwarded to Tempus Public Foundation by the Sending Partner until the end of February 2023. **Applications will be considered only if the applicant is nominated. No other applications will be considered.**

### 3.5. Selection Procedure

#### 3.5.1. First Round of Selection: technical check and the nomination of Sending Partner (January-February 2023)

Applications that are only saved in the online system, but not submitted, will be automatically rejected. The applications successfully submitted in Tempus Public Foundation's online application system are checked first. This is called a technical check and it is done by Tempus Public Foundation. During this step, we check the basic eligibility criteria; for example the age, citizenship, the previous scholarships, and check if the applicant has applied for a scholarship type and/or study programme that is available within the framework of the programme and that is available for the applicants of the particular sending country/territory. Also, we will formally check if the required documents are uploaded in the application system or not, and check if the Statement for Application is accepted in the system. However, it is the Host Institution that checks whether the uploaded files and their quality can be accepted and whether these documents meet their entry requirements or not.

Applicants will be automatically rejected during the technical check if they

- do not successfully submit their application in the online system until the 16 January 2023
- are Hungarian citizens, hold a Hungarian dual citizenship or they are persons granted a refugee status, enjoying temporary protection, admitted for subsidiary protection or granted humanitarian protection,
- have a citizenship that is different from the sending country/territory they apply through,
- have submitted multiple applications with more than two study programmes
- have submitted applications from more than one account registered to our system
- have submitted multiple applications with more than one sending partner
- do not accept the Statement for Application (please see Annex 2 for template) in the online system,
- are former Stipendium Hungaricum Scholarship Holders or self-financed students at a Hungarian higher education institution in cases described in Section 2.2. about non-eligibility,
- were awarded the Stipendium Hungaricum scholarship for the 2020/21 or for the 2021/22 or for the 2022/23 academic year, but after accepting their scholarship, did not travel to Hungary and did not start their studies, nor did they notify Tempus Public Foundation of this fact until 31 August,
- have postponed their scholarship awarded in the 2021/22 application round, but did not travel to Hungary and did not start their studies next year, nor did they notify Tempus Public Foundation of this fact until 31 August.
- have provided any false information during the application process.

The eligible and successfully submitted applications are forwarded to the responsible authorities of the Sending Partners for review and pre-selection. The exact methods and guidelines of the Sending Partners' selection are determined by the Sending Partners. After the selection decision of the Sending Partner, a nomination list - including a reserve list - will be issued and forwarded to Tempus Public Foundation by the Sending Partner until 28 February 2023.

**Applicants can only apply through sending countries/territories of their own nationality. Sending Partners can only nominate applicants with the same citizenship. Only nominated applicants will be considered for the second round of selection: the institutional evaluation.**

### 3.5.2. Second Round of Selection: the institutional evaluation (March - May 2023)

The application materials of the nominated applicants (including the reserve list) are forwarded to the Host Institutions for professional evaluation. The institutions will also run a formal check first to see if all the documents submitted by the applicants meet the requirements of the Call for Applications and the minimum entry requirements of the selected study programme(s).

Applicants with a valid, formally correct application that meet the minimum entry requirements can proceed to the institutional entrance examinations. Each applicant can participate in up to two institutional entrance examinations – in accordance with their submitted applications.

The exact dates and methods of the entrance examination vary by institution. **Each applicant will be individually informed about further details (e.g. date of examination) directly by their selected Host Institution(s).**

As applicants can apply for up to two study programmes, the institutional examinations are conducted in two rounds.

1. Applications for the **first selected study programmes** are considered first by the universities. The examination process for the first selected programmes can be expected between 18 March and 30 April 2023; however, the dates are indicative.
2. Applications for the **second selected study programmes** are considered afterwards. The examination process for the second selected programmes can be expected between 18 March and 20 May 2023; however, the dates are indicative.

Depending on the selected Host Institution(s)' schedule of examinations, it is possible that there will be no entrance examinations for the second study programme selected by the applicant – in case the applicant is already approved for the scholarship for the first selected study programme.

The applicants are evaluated on a 100 point scale. The final examination results and the examination points given by the Host Institutions are then forwarded to Tempus Public Foundation.

**Important note: the minimum score that is required to be achieved is 56 points (on a 100 point scale). No applicants shall receive a scholarship offer with an examination result below 56 points.**

### 3.5.3. Allocation of Admitted Applicants (May-June 2023)

Tempus Public Foundation is responsible for the allocation of the applicants. In case of all countries participating in the programme, the allocation of the applicants and the selection of Scholarship Holders depend of the allocation principles described in the Operational Regulations (see **Annex 1**) of the programme. In general, the principles the decision is made by are the following:

1. the content of the relevant bilateral agreements in effect between Hungary and the Sending Partner,
2. the capacity (minimum and maximum number of available places) of the university's specific study programme (you can check it in the online application system: <https://apply.stipendiumhungaricum.hu/>,
3. the preference order of the selected study programmes on the application form (please read Section 2.4 carefully),
4. the examination results (100 points maximum) given by the Host Institutions and the points based on the ranking order of the Sending Partners' nomination lists

Apart from these, in order to support student diversity, the number of eligible applicants from the same country may be limited in case of certain study programmes due to the limited number of places offered in the Stipendium Hungaricum programme (e.g. medical programmes).

Applicants can receive one of the following statuses:

- approved Scholarship Holder, or
- conditionally approved Scholarship Holder (in case any missing documents need to be uploaded), or
- approved on waiting list (can only be approved if scholarship holders withdraw), or
- rejected.

The application of a person identified by the competent national security services as a potential risk can be rejected by the Board of Trustees of the Tempus Public Foundation.

The applicants will be informed about the application results around the end of June 2023 (please see timeline at Section 3.4.3). Please note that applicants can expect only one information email from Tempus Public Foundation about the results. Depending on the allocation results, applicants can expect this letter anytime throughout June and July; therefore we would like to ask for your patience. Please note that we are not able to reply to individual requests asking for the results and all applicants will be informed via the online system.

### 3.6. Acceptance of the Scholarship

Those who do not accept their scholarship until the deadlines below are automatically considered withdrawn from the scholarship.

Applicants who are awarded the scholarship shall not receive a Scholarship Holder status if they:

- withdraw from the scholarship in a written form (sent to both Tempus Public Foundation and the Host Institution) or via the application system, or
- fail to upload their missing application documents until 1 August 2023, or
- fail to accept their scholarship until the given deadline, or
- withdraw their data protection (GDPR) consents, or
- provided false information during the application process.

#### 3.6.1. Acceptance of Scholarship for Approved Scholarship Holders

In order to gain a Scholarship Holder status, approved applicants must accept their scholarship and consent to the Operational Regulations of the programme (see Annex 1 for the Operational Regulations) in the online application system within the time frame written in the notification e-mail (usually this is within two weeks after receiving the notification e-mail about the application decision, but it can be a shorter period) **but no later than 1 August 2023**.

#### 3.6.2. Acceptance of Scholarship for Conditionally Approved Scholarship Holders

If the applicant is conditionally approved because they have any missing documents that could be uploaded after the application deadline, all of the missing documents need to be uploaded via the



online system immediately after receiving all documents (and after receiving the notification about the conditional status), and no later than 1 August 2023. Please see details in Section 3.3. about missing documents.

Conditionally approved Scholarship Holders must accept their scholarship and consent to the Operational Regulations of the programme (see **Annex 1** for the Operational Regulations) in the online application system **within the time frame written in the notification e-mail** (usually this is within two weeks after receiving the notification e-mail about the application decision, but it can be a shorter period) **but no later than 1 August 2023.**

## 4. Studying in Hungary

Any possible changes in the entry and enrolment system due to the COVID-19 pandemic situation will be posted on our website: <https://stipendiumhungaricum.hu/>. Please consult the website regularly.

### 4.1. Visa Applications

You are requested to **start your visa application process immediately** after receiving the positive decision about the scholarship. Officially, it may take 30 days until a visa is issued. In order to apply for visa to Hungary, you need to contact the competent consular office. For more information please, contact the website of the Hungarian Ministry of Foreign Affairs and Trade (<https://konzinfo.mfa.gov.hu/en> ) and the Directorate-General for Aliens Policing (<http://oif.gov.hu/index.php?lang=en> ).

Please note that the citizens of some countries do not need a visa to enter Hungary due to the Visa Waiver Agreements. At the time of writing, these countries include: Albania, Argentina, Brazil, Bosnia and Herzegovina, Chile, Costa Rica, Colombia, Georgia, Israel, Japan, Malaysia, Marshall Islands, Mexico, Moldova, Montenegro, North Macedonia, Panama, Peru, Republic of Korea, Saint Lucia, Serbia, Seychelles, Singapore, Taiwan, Ukraine, United Arab Emirates and Uruguay – as well as the passport of the special administrative territory of Hong Kong and Macao.

Please make sure to visit the Consular Services website for up-to-date information about your country: <https://konzinfo.mfa.gov.hu/en/visa-free-travel-hungary>.

Please note that the Scholarship Holder status does not automatically guarantee a visa.

### 4.2. Arrival and Enrolment

We highly recommend all applicants to visit our Study in Hungary website ([www.studyinhungary.hu](http://www.studyinhungary.hu)) for detailed information about life and education in Hungary. As mentioned in Section 1.3, please also check the expected living expenses with our [Cost of Living Calculator](#).

Scholarship Holders are required to inform the institutional Stipendium Hungaricum coordinator of their Host Institution (please see contact details on our website) about their expected date of arrival 30 – but not less than 15 – days before arrival.

Successful applicants are expected to make their own travel arrangements to Hungary – no financial provisions will be provided for travel expenses by the Hungarian side. In accordance with current legislations, Scholarship Holders are entitled to be exempt from the payment of any fees related to their admission to Hungary. No visa, administrative services or additional contribution is given to family members or accompanying persons.

Please note that the Stipendium Hungaricum Scholarship Programme does not fully cover all upcoming costs of the Scholarship Holder. It means that the students need to add their own financial resources in order to cover all living expenses in Hungary. All applicants are highly advised to check the expected living expenses both in Hungary and in the city that they wish to live in before applying; please do check our Cost of Living Calculator by clicking here: <http://www.studyinhungary.hu/living-in-hungary/menu/your-costs-of-living.html>

Scholarship Holders are expected to obtain their visa, arrive in Hungary and **register at the Host Institution no later than 30 September 2023** (for study programmes starting in the Autumn Semester) – or the date set by the Host Institutions. The applicant who is granted the scholarship must enrol to the Host Institution in the semester in which they were granted admission.

In principle, it is **not possible to postpone the start of the scholarship studies** to another semester or academic year – except for very special, unforeseeable, force majeure cases described in the Operational Regulations, with the special approval of Tempus Public Foundation. Therefore, in principle if the Scholarship Holder does not enrol until 30 September 2023 – or the date set by the Host Institutions, they will be automatically excluded from the scholarship programme.

Please note that Scholarship holders will take part in medical examinations organized by universities upon their arrival (it is free of charge for Scholarship Holders).

## **4.3. Rights and Obligations**

### **4.3.1. Operational Regulations, GDPR and Student Contract**

**All Scholarship Holders are bound by the Operational Regulations of the Stipendium Hungaricum Programme. Please make sure to read it carefully in Annex 1. The following text contains extracts from the Operational Regulations; however, all Scholarship Holders must read the full text of the regulations.**

Scholarship Holders are required to sign a scholarship contract with the Host Institution including study-related details and the rights and obligations of the Scholarship Holders (see sample on our website or at the end of the Operational Regulations).

**The Stipendium Hungaricum scholarship is a contribution to the living costs of the Scholarship Holder only, therefore – within the framework of the programme – visa-related assistance, additional allowance and administrative services are not provided for any accompanying people or family members. The legal entity of the scholarship contract is exclusively the Scholarship Holder and the Host Institution.**

The Scholarship Holders are expected to follow the regulations of the Host Institution and continue their studies in good faith, to the best of their abilities, in order to meet the academic requirements of the study programme and thus finish the programme successfully. By accepting the scholarship, the

Scholarship Holders agree to participate in the alumni system of the programme that support the maintenance of relationships with the Scholarship Holders and facilitates the flow of information – such as the alumni website, alumni events and surveys about the satisfaction of students, career monitoring and the evaluation of research activities.

Please note that the Operational Regulations of the Stipendium Hungaricum Programme can be subject to change, and the Scholarship Holders are always bound by the prevailing regulations at any given time.

Please note that, in accordance with the General Data Protection Regulation (GDPR) in European Union law, all applicants need to give consents regarding data protection and accept the Privacy Policy (see Annex 3) in order to be able to submit an application. These consents appear in the online application system after registration.

#### 4.3.2. Staying in Hungary

**Scholarship Holders are obliged to live and study in Hungary; therefore, they are not allowed to live habitually in any other country during the study period, otherwise their scholarship holder status will be terminated.**

#### 4.3.3. Other Scholarships and Double Financing

As the Stipendium Hungaricum scholarship covers the entire period of the studies, the Scholarship Holders are not entitled to use financial support for getting enrolled in full time or partial (exchange) study programmes outside Hungary (e.g. Erasmus +, CEEPUS, Campus Mundi). They can only participate in conferences or research activities that are professionally relevant for their studies. These activities should not exceed 14 days or in any way prevent the student from habitually living in Hungary.

Applicants are also not eligible to receive the Stipendium Hungaricum scholarship in case they have another concurrent scholarship from the Hungarian central budget for studies in Hungary. If the Scholarship Holder was awarded more than one scholarship, they have to choose one of the scholarships and withdraw from the other ones. However, the Host Institutions are allowed to provide additional financial support for the students on a social, performance-related, or other basis.

In accordance with the regulations of Government Decree 51/2007. (III. 26.), Scholarship Holders are entitled to be awarded with the National Higher Education Scholarship ("nemzeti felsőoktatási ösztöndíj")

#### 4.3.4. Termination of Scholarship Status

The details and cases when the scholarship status is terminated are listed in the Operational Regulations of the programme (see Section IV. of Annex 1).

In accordance with the Operational Regulations of the programme, the scholarship status is terminated if

- the student status of the scholarship holder is terminated by the host institution,
- the scholarship holder withdraws from the scholarship in a written form (sent to both Tempus Public Foundation and the Host Institution),
- after accepting his/her scholarship, the scholarship holder does not travel to Hungary and does not start his/her studies (if he/she does not notify Tempus Public Foundation of this fact, he/she cannot apply in the next 3 years
- the scholarship holder had obtained their degree at the study programme supported by the scholarship,
- the Scholarship Holder does not comply with the regulations of the programme regarding the obligation of living habitually in Hungary,
- the Scholarship Holder does not fulfil their obligation to participate in medical screenings, and their additional obligations set out in the healthcare protocol, or he is deemed unfit during the obligatory medical examination,
- the scholarship holder receives Hungarian citizenship (including those with dual citizenships), granted a refugee status ("menekült), temporary protection ("menedékes"), or admitted for subsidiary protection ("oltalmazott") or granted humanitarian protection ("befogadott"),
- as a result of institutional disciplinary or criminal proceedings against the scholarship holder, the scholarship holder is expelled, and for this reason the Public Foundation asks the host institution to terminate the scholarship status,
- in other cases described in the Operational Regulations of the programme in effect.
